### Mailboxes (Stain 3-5yr Cycle/Boxes~15yr)

This year we will be staining the cedar mailbox banks and going through them to repair any damage. The mailboxes were replaced in 2019 and are still in good shape so those will not be replaced.

#### Pond

Maintain the water quality, silt levels, reduce overgrowth, eliminate noxious weeds, and reintroduce native grasses/flowers/plants. We also continue to remove debris from the three rainwater runoff drains and clean them on a regular basis. In addition this year we will be removing tree limbs that were damaged from high winds in the storms last year. Mowing will continue around the pond throughout the year.

*Please note:* The pond buffer zone is maintained by the association in partnership with the City of Champlin and it is not acceptable to plant in this area or dump debris. If homeowners dump debris (grass clippings, leaves, compost bins, twigs & branches) or plant in the buffer zone they will be charged for cleanup.

### Hedge Maintenance (Annually)

Continue with the maintenance of mulch in addition to trimming.

# Boulevard

We continue to maintain the boulevard which includes mowing, fertilizing, and completing the fall cleanup. In addition we will continue the regular maintainance of refreshing mulch, trimming trees, and edging.

### Sprinkler System (Annually)

In 2023 we replaced multiple sprinkler heads that were damaged. We will continue to use Stoltenberg / Mid-State Lawn Irrigation for sprinker & water startup/shutdown and repairs.

### Monument (Stain 3-5yr/Paint ~10yr/Flowers Annually)

Annual planting, mulch refresh, and trimming of the bushes/trees will continue in 2024. We will also complete repairs as needed.
